When I was 13. I dropped in on a Troop meeting to help a friend fulfill one of his rank requirements. I didn't really expect to join the Troop, but the tremendous feeling of camaraderie and brotherhood within the Troop quickly convinced me that this was an organization that I knew I had to become a part of. I had only attended a few meetings before our first campout, it was a whitewater rafting and biking trip in Western

Pennsylvania. After such an incredible trip, I knew I was hooked and from that weekend forward, Scouting has helped me to learn valuable life lessons I'll use for the rest of my life.

### **Distinguished Eagle Scouts**

The Distinguished Eagle Scout Award (DESA) is a distinguished service award of the Boy Scouts of America. It is awarded to an Eagle Scout who has achieved extraordinary national-level recognition, fame, or eminence within their profession and/ or service to the nation, and has a strong record of voluntary service to their community. Stringent criteria begins with a minimum of 25 years from the official record date the Eagle Scout rank was earned, a nomination process, selection committee review, and approval by the National Eagle Scout Association. It is one of only two BSA awards presented to adults dependent upon the recipient's having been awarded Eagle Scout as a youth; the other is the NESA Outstanding Eagle Scout Award (NOESA).

The DESA was first introduced in 1969 and is awarded by the National Eagle Scout Association. To date there have been 15 recipients in Del-Mar-Va Council. Those recipients are William Poole, Marvin Smith Sr., Francis Morris, Randall Murrill, William Hershey, H. Gordon Smyth, John Croom III, William Topkis, Thomas Short, Jon Andes, John Akridge III, Ronald Siarnicki, Clifford Berg, Ronald Blanck and Pat Confalone. Thank you all for your service to Scouting.
